

## **Application Materials for Undergraduate Program in Chinese**

All application materials and information provided by applicants must be authentic, accurate, and complete. Otherwise, the applicant will be disqualified from applying, enrolling, or studying. Please upload scanned copies of the original documents listed below through the ["Study@SJTU" Application System](#).

1. Passport information page valid for more than 6 months. Once admitted, passport information cannot be changed until enrollment registration is completed.
2. Senior high school diploma or equivalent qualification. Prospective graduates may provide an official high school transcript as proof of graduation.
3. High school profile. The content should include the school's overall introduction, admission requirements, enrollment rate, curriculum system, grading system, university acceptance of graduates, etc
4. Personal statement with the applicant's signature.
5. Two recommendation letters signed by the recommender. At least one must be provided by the applicant's current high school teacher.

### 6. Academic certificates:

6.1. High school transcript (covering all courses completed during high school). Prospective graduates must submit a transcript of all high school courses completed up to the application date.

6.2. Standardized international test scores or national/regional unified high school graduation or university entrance exam results, such as SAT (code: 9184), AP, ACT (code: 3038), A-Level, IB (code: N010601), UEC, etc. If the above results cannot be provided, a written explanation can be submitted.

6.3. [Test score of the China Scholastic Competency Assessment \(CSCA\)](#). Specific subject requirements for the CSCA can be found in the List of 2026 SJTU Undergraduate Program in Chinese for International Students. Applicants who have not yet taken the CSCA may submit other application materials initially. Those who pass the university's selection process will receive a pre-admission notice and must supplement their CSCA scores by June 30, 2026. Upon passing the final selection, a formal admission notice will be issued.

### 7. Language certificate:

7.1. Chinese language proficiency proof, with at least one of the following materials required:

- (a) HSK results: HSK Level 5 with a score of 200 or above (with Writing  $\geq$  60), or

HSK Level 6 with a score of 180 or above (with Writing  $\geq$  60).

(b) Other equivalent proof, such as documentation indicating Chinese as a native language.

(c) [Application form for One Year of Chinese Language Courses](#). This applies only to conditionally admitted applicants whose Chinese proficiency does not yet meet the requirements and who require one year of Chinese language training.

7.2. English language proficiency proof, with at least one of the following:

(a) TOEFL scores (code: D070).

(b) IELTS scores.

(c) Other supporting materials, such as proof of English native speakers, English language study certificates, etc.

8. Applicant's birth certificate

9. The nationality or household registration of both the applicant's parents, such as passport or ID card.

10. Applicants with one or both parents who are Chinese citizens must provide:

10.1. Certificate of the applicant's foreign nationality obtained at birth or afterward.

10.2. For applicants who acquired foreign nationality at birth:

(a) If one or both parents were Chinese citizens and had permanent residence abroad at the time of the applicant's birth, provide the corresponding permanent residence proof of the parent(s).

(b) If one or both parents were Chinese citizens and did not have permanent residence abroad at the time of the applicant's birth, provide a certificate of the applicant's renunciation of Chinese nationality for at least four years by April 30 of the application year.

10.3. For applicants who are originally Chinese citizens and later acquired foreign nationality, provide proof of cancellation of their Chinese residence registration and renunciation of Chinese nationality for at least four years by April 30 of the application year.

10.4. All visas, residence permits, and entry/exit records for China, starting from the applicant's first passport.

Note: Applicants who previously held a "People's Republic of China Travel Document" or "People's Republic of China Exit and Entry Permit" must provide the relevant documentation as in section 10.3.

11. Applicants under 18 years old by September 1 of the application year must submit a [Guardian Guarantee Form](#).

12. Proof of financial guarantee with a deposit of no less than RMB 100,000 (or equivalent in foreign currency).

13. Award certificates (if any).

14. Applicants for Visual Communication or Human Habitat Design must submit portfolios.

15. Other supportive materials required by SJTU.

NOTE:

- ① Items or certificates listed in 6.2, 6.3, 7.1, 7.2 must be obtained within two years.
- ② Materials sent directly by the high school to the university may be emailed to [isc.d@sjtu.edu.cn](mailto:isc.d@sjtu.edu.cn) with the student's name, application number, and document name in the subject.
- ③ If any documents are not in Chinese or English, notarized translations in either language are required.
- ④ Hard copies of supporting materials are not necessary during the application process.
