I. Faculty

1. Overview of Faculty

KoGuan Law School has now 62 full-time faculty members. Among them, 26 are professors, 18 associate professors and 2 distinguished Professor awarded by the Changjiang Scholars Program of Ministry of Education. Thanks to the KoGuan donation program, the Law School is currently undergoing a recruitment effort to attract and hire the most qualified candidates and the total number of the faculty is expected to reach about 80 in the future, including 3 KoGuan Presiding Professors, 10 KoGuan Chair Professors, and 10 KoGuan Youth Scholars. In addition to our full-time faculty members, we have also appointed a number of adjunct professors.

III. Achievements

The school has become an important force in Shanghai and throughout the country in legal research. It has undertaken important research tasks including National Social Science Foundation projects, hosted important conferences including the Congress of the Law of the World and the World Environmental Law Conference, and has achieved fruitful results.

We are committed to conduct research on academic frontiers, emphasize cross-disciplinary

research, achieve the first class scholarship that meets the important strategic need of the state, and build the SJTU School of legal scholarship.

In only a few years, we have made significant progress in academic research and our scholarship has already had an impact and attracted attention from both domestic and international legal academic communities.

Between 2009 and 2014, KoGuan Law School was awarded 23 National Social Sciences Fund projects (including one major project). More than 370 CSSCI articles, 33 SSCI articles, and 2 SCI article were published.
